General Instructions

- 1) Only schools affiliated to CBSE which are members of Thrissur Central Sahodaya are eligible to take part in the Sahodaya Kids' Fest.
- 2) The competitions in various items are conducted in two categories.

Category 1 – Kinder-garten (LKG & UKG)

Category 2 – Classes I and II

- 3) Following program will head key position for the conduct of Kids Fest
 - 1 Gn. co-ordinator TCS Gn. Secretary
 - 2. Gn. Convenor Principle Host School
 - 3. Convenor (Finance) Treasurer TCS
- A) Duties of Gn. co-ordinator

He will be in charge of conducting the programs. He has to make arrangements to appoint Judges. Stage Managers, Time keepers, IT cell etc..drawn from the efficient and experienced teachers of different schools to conduct the festival.

Asst. Manager for each stage will be from host school. Appeals will be received by Gn. Co-ordinator.

B) Duties of Gn. Convenor

- 6) Finance: The funds for the Kids' Fest shall be raised through four sources.
 - a. Registration Fee from member schools
 - b. Individual Participation fee
 - c. Sale of food coupons
 - d. Sponsorship
- 7) Fee: The Fee (School Reg. Fee + Individual Participation Fee) shall be remitted only as DD drawn in favor of "Thrissur Central Sahodaya". Payable at Chalakudy in Federal Bank Branch North Chalakudy.

School Participation Fee – Rs. 3000/-

Individual child – Rs. 500/-

8) Registration: Registration will be done online through the TCS official website www.thrissurcentralsahodaya.com. Once the online registration is over, schools can generate the Participant IDs and Consolidated List of Participants from the same site. Once the IDs and Consolidated Lists are generated, they must be verified carefully and corrections, if any, must be incorporated before finalizing the same. Corrections of any kinds shall be incorporated at a later date given by Gn. Convenor.



9) Rules & regulations:

- a. A student can take part only in one individual item and in any one of the group items.
- b. Participants are not allowed to perform any item wearing their school uniform or ID card They should be in color dress only in the campus and should wear the festival ID card always.
- c. The participants are instructed to report one hour prior to the stipulated time to collect the chest numbers.
- d. A grace of 15 seconds will be given for each stage item.
- e. Chest numbers should be returned to the stage volunteer as soon as the competition is over
- f. A meeting for the Team Managers of schools participating in Sahodaya Kids' Fest will be held at the venue school. The Team Manager has to submit the ID cards along with the Consolidated List of Participants during this meeting.

10) General Instructions regarding the competitions:

- a. For each group item, two standbys can be registered in order to substitute the performers in the event of an emergency. However, substitution while performing on the stage will not be allowed.
- b. Certificates and prizes will be given only to those students who perform on the stage
- c. Students registered as standbys need not pay any registration fee. They will not be issued any Participation Certificate, if they have not performed on stage.
- d. The qualifications and credentials of the judges shall be announced on the stage, before the commencement of each item.
- e. Once a competition is over, the stage managers shall do the tabulation work.
- f. The secretary TCS shall appoint qualified and competent judges to judge the items. There shall be three judges for each item.
- g. Identity Card issued by the Sahodaya is compulsory for all participants, Escorting Teachers and Makeup Artists.
- h. There will be three lights on the stage Red, Green and Yellow. Green indicates the start- ing of an item. Yellow indicates there is only one minute left. Red indicates the time limit is over. A grace of 15 seconds is provided for every stage item. If a participant exceeds this time limit, he/she is not eligible for any prize. In the stage where light indicator is not provided, bell system will be followed.
- I. In case, a technical fault occurs before half the time of an item, that event will be restarted; but if it happens after half time, that item can be performed again at the end of that particular cluster.
- J. Before starting the judgment, the Stage Manager will announce the profile of the judges in each stage. So the profiles of the judges are to be given early enough to make necessary arrangements

AWARDS AND TROPHIES

- 1. The participants who secure first, second and third positions with a minimum of 50% marks shall be awarded merit certificates in both individual and group items.
- 2. Participation certificates shall be given to all participants other than the winners of the first, second and third places.
- 3. No additional points are allotted for securing First, Second or Third Places.
- 4. Fixing of Grades and Points for Individual Items.

Grade A	70% and above	5 points
Grade B	60% to 69%	3 points
Grade C	50% to 59%	1 point

5. Fixing of Grades and Points for Group Items

Grade A	70% and above	10 points
Grade B	60% to 69%	6 points
Grade C	50% to 59%	2 point

- 6. No grade/points for 49% marks and below.
- 7. Schools securing first, second and third position in total points shall be awarded Overall Champion, Runner Up and Third Place Trophies respectively.
- 8. Schools securing first, second and third position in every category shall be awarded with Trophies.
- 9. Individual trophies are instituted for the first, second and third positions in every category for every item.
- 10. For Group Items, the school winning any place(First, Second or third) will be awarded with a trophy and the participants are awarded with individual trophies and Merit Certificates.

APPEAL

- 1. In case of disputes, if any, an appeal shall be filed in the specified Pro forma, along with an appeal fee of Rs.2000/- within one hour of the announcement of the result.
- 2. Appeal shall be filed only by the Principal/Team Manager of the schoolconcerned.
- 3. If the decision taken by the Appeal Committee is favourable to the applicant, the appeal fee shall be returned,. If it is not favourable, the same shall be forfeited.
- 4. The Appeal Committee shall scrutinize the matter in detail, considering the legal and technical aspects of the issue. A detailed order shall be passed by the Appeal committee in the prescribed form.
- 5. The appeal Committee shall take a decision on the appeal, on the same day of receiving the appeal.
- 6. The appeal committee shall have the right to accept or reject an appeal after scrutiny.
- 7. The decision of the appeal committee shall be final and bindingall.

FOOD & ACCOMODATION

- 1. Food and refreshments shall be arranged free of cost at the venue for the participants, one Escorting Teacher for every ten students per day, and the officials.
- 2. Any request for additional snacks and lunch for teachers/staff or parents has to be made in advance. The charge for additional snacks and lunch will be payable as per the instruction of the Gn. Convenor.
- 3. Detailed Menu will be distributed among the participating schools well in advance.
- 4. Classroom accommodation shall be provided to the participants for make up.

PROGRAMME CO-ORDINATION RULES FOR T.C.S AND VENUE SCHOOL

Annexture - 1

- 1. TCS shall be the only official body to decide up on all matters regarding the Kids' Fest.
- 2. The venue school shall abide by the rules and regulations of the TCS.
- 3. The Registration fee will be channeled through the TCS. The expenditure on judges shall be met from this amount. The remaining amount shall be handed over to the venue school.
- 4. Banners, posters, arches and other hoardings for the publicity of the Kids' Fest shall bear the name of the TCS prominently.
- 5. All the stages shall display banners with the name of TCS.
- 6. An Office room shall be provided for the officials at the venue schools(s). They shall have the provision to use the facilities available in the school with the permission of the authorities concerned.
- 7. Food and accommodation of the TCS Officials, Convenors, Joint Convenors and the judges shall be arranged by the Venue School(s).
- 8. As it involves kids of Kindergarten and primary classes, effort must be made to get the programmes of one category completed on the very sameday.
- 9. Care also must be taken to get all the programmes completed before 5.00 pm.
- 10. Chief Petron/ The President of the TCS shall preside over all the meetings. The details of the programme with regard to the Kids' Fest shall be fixed in consultation with the TCS officials.
- 11. The Office bearers of TCS shall be accorded prominence in the functions.
- 12. A separate file shall be maintained for all the paper works regarding the Kids' Fest. On completion of the Kids' Fest, this shall be submitted to the General Secretary along with the photographs/CDs of the function as well as the account statement.
- 13. Proper communication shall be maintained with the TCS Officials with regard to the progress and proceedings, before, during and after the Kids' Fest.
- 14. The Kids' Fest is a prestigious programme involving all the CBSE Schools in T.C.S. Hence, every attempt shall be made to make it grand, colorful and successful.
- 15. TCS shall extend all possible help, support and guidance to ensure that the Venue School gets all the publicity, popularity and fame of hosting this mega event.
- 16. As the main advantage of the fest is the publicity received for the school; T.C.S will be providing the minimum expenses to conduct the fest. The allotments of funds will be done by treasurer T.C.S. All other expenses like bringing celebrities, decoration, publicity etc.. should borne by the school. The host convenor will submit a budget to the treasurer; who in turn will place it before T.C.S for approvals. No extra funds will be given by treasurer for any other extra purpose.

INFORMATION TO THE JUDGES

Annexture - 2

- 1. Every judge shall sign a declaration in the prescribed Pro format o the effect that none of his/her pupil/learner of relative is participating in that particular item.
- 2. A separate room is arranged for the judges when they are not involved in the judgment.
- 3. Before going to the judgment seat, every judge shall deposit his/her cell phone with the Judges in Charge and get a slip against it.
- 4. In no case there shall be any public contact. Even talking to the people in the premises is to be avoided.
- 5. Judgement of an item in a particular category will take place at a stretch inclusive of all clusters.
- 6. There is no separate lunch break. As and when one particular category competition is over, the judges shall be escorted to the mess hall for lunch by the judges in charge. If the item prolongs, Tiffin will be served at the judgment seat which they shall consume when a particular cluster in a category gets over.
- 7. There will be three lights on the stage Red, Green and Yellow. Green indicates the start- ing of an item. Yellow indicates there is only one minute left. Red indicates the time limit is over. A grace of 10 seconds is provided for every stage item. If a participant exceeds this time limit, he/she is not eligible for any prize. In the stage where light indicator is not provided, bell system will be followed.
- 8. In case, a technical fault occurs before half the time of an item, that event will be restart- ed; but if it happens after half time, that item can be performed again at the end of that particular cluster.
- 9. All the non-stage items are to be valued at the venue itself.
- 10. Before starting the judgment, the Stage Manager will announce the profile of the judges in each stage. So the profiles of the judges are to be given early enough to make necessary arrangements
- 11. Fixing of Grade and Points for Individual group items.

Grade A	70% and above
Grade B	60% to 69%
Grade C	50% to 59%

12. No grade/points for 49% marks and below.
